## 1. Purpose of the document

The document provides guidance for ITFC officials for the player registration, transfer, and international legitimation.

The document is prepared and approved by the ITFC.

## 2. Player base

Each player who attends any International Tournament or local Tournament which is part of the International calendar should have player registration number.

### 2.1. Player registration number

Player registration number can be obtained from ITFC player registration committee. To obtain player registration number the following details are mandatory:

- First name
- Last name
- Nationality
- Club
- Birth date
- Category:
  - Sectorball
  - 12 Touch
  - Other

Each player will be assigned with a unique identifier which will be used for further identification.

Identifier details: Country abbreviation + XXXXXX where XXXXXX are numbers

Sample identifier: BRA000001, HUN000001, ROU000001, ARG000001, SRB000001

### 2.2. Player registration fee

Player registration fee is determined and accepted by ITFC management and Congress. Player registration fee must be paid every year when the player has active appearance in international championship.

## 3. Transfer

### 3.1. Rules

Each country has their own transfer rules. Transfer limitations, timeframes, club appearances in national championships are defined by local country Federations. ITFC has no control over local regulations.

### 3.2. International Club appearance

Within one calendar year each player can play only for one club in any International Club Championships. This rule does not apply for Individual tournaments.

International Club Tournaments are the following:

- Champions League - Europe
- South America Club Championship
- Intercontinental Cup

### 3.3. International Individual and country appearance

Each player must have country citizenship or passport to represent his country on the following International Tournaments:

- World Championship
- European Championship
- South America Championship

### 3.4. Double citizens

Double citizens can play for multiple countries however the following restrictions are applied:

- During official registration both citizenships should be provided
- Within one calendar year one player can play and represent only one country
- Each country membership re-registration should be submitted to ITFC at least 4 weeks before the official tournament starts.
